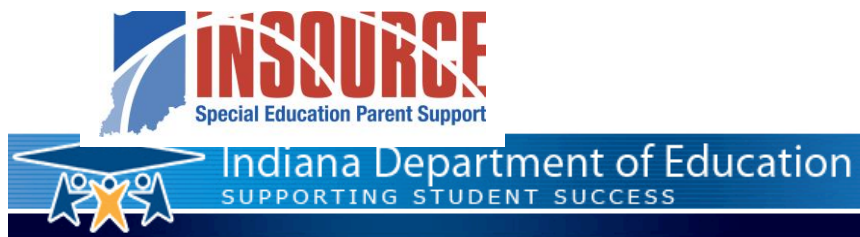

Therefore, the services and accommodations provided are intended to reasonably remove a barrier. The office does not provide treatment or teach students how to minimize the impact of their disability. Instead, reasonable modifications are made to a course, program, or facility to allow the same access as experienced by students without disabilities. An accommodation is considered reasonable only if it does not significantly alter the essential components of a course or program.</p>
